
How Giving can Benefit You

The reality of charitable giving in Canada is that there are ways in which giving gifts can also benefit your financial situation. As a result, you have the capability and opportunity to donate more to the charities whose mission God has placed upon your heart and that you care for.

Features and Incentives of Giving

- + You can impact our culture and God's Kingdom by strengthening the charity to fulfill its mission.
- + For individuals the tax savings could range from 40-50%, depending on your province, which increases your capacity to give more.
- + Any unused donation receipts can be carried forward for up to five years.
- + Donations can be claimed up to 75% of your net income each year. In the year of death, the donation limit is 100% of your net income and can also be applied to the tax year prior to death.
- + The Canadian government encourages individuals and corporations to give by providing the taxpayer several advantages and options in their generosity to charities.
